▶ LIMITED MATERIALS WARRANTY

C-Cure guarantees for a period of 5 years from the date of installation that the herein listed products will be free from manufacturing defects and will perform according to C-Cure's most current published specifications. Warranted installations must be installed in accordance with C-Cure's written specifications, guidelines, and are subject to the conditions and limitations stated therein.

C-Cure products must be used exclusively in conjunction with the complete C-Cure installation system as stated herein. In addition, all C-Cure products used must be of good condition and less than one year old from date of manufacture.

This warranty does not extend to and C-Cure is not responsible for structural failure or workmanship that is not in accordance with standard industry practices, guidelines, standards, or C-Cure's published instructions. This warranty does not extend to and C-Cure is not liable for losses due to delays or any other consequential damages.

The liability of C-Cure under this warranty is limited to replacement of only that portion of the installation that is proven to be defective. Such cost to C-Cure shall not exceed the original per square foot cost of the installation. Proof of product purchase cost may be required.
